Deficiencies: equipment and controls 20 years old. (near end of useful life) Harder to repair/replace

Inflow/infiltration (extra clean water that infiltrates i.e. ground water) we are treating clean water.

Dewatering system is labor intensive.

Existing disinfection is overwhelmed at peak flows.

Goals: address deficiencies, improve city's ability to collect and treat sewer flows.
